- Please send a copy of your animal's registration with entry form, both Show and Sale. Acceptable registries are ADCA, PDCA or Legacy only.
- Please bring original registration papers in order to complete transfer of sale animals to new owners,
- Copies of genetic testing paperwork should also be with every sale animal, if already completed.
- This show is sponsored by OVDBA and friends of OVDBA. We will follow ADCA show guidelines see their site for full rules and regulations.
- Friday check-in, the animals will not be unloaded until inspected.
- Ohio law requirements:
 - **Ohio's code Importing requirements for cattle**: <http://codes.ohio.gov/oac/901%3A1-17>
 - **Ohio's code for Exhibition of Animals**: <http://codes.ohio.gov/oac/901%3A1-18>
 - ALL out of state animals must be accompanied by vet health check paperwork in order to participate in the show/show.
 - SALE ANIMALS ONLY - Bulls 12 months and older must have a Trich test in order to enter the state.
 - SALE ANIMALS ONLY - Virgin bulls 12 to 24 months must have vet certification stating that the bull has not been used for breeding -
- OVDBA reserves the right to remove any animal that poses as a threat to people and/or other animals. If this animal is deemed unsafe, it will be required to be trailered and not eligible for sale or show placing.
- Non-halter broke animals will be allowed in the sale but are to be left in trailer for safety reasons.
- Sale animals will be highlighted in the show book. Ad info must be received by April 30, 2023
- You do not have to show an animal in order for it to be in the sale.
- Bulls for sale should be geno-typed and it is highly suggested that they have chondro and PHA testing completed along with Trich test or affidavit completed so they are ready to cross state lines.
- Total body fitting is prohibited. This includes sculpting of the hair when clipping and then using adhesives, wax, or mousse, to shape the coat to hide animal flaws.
